

FACTS	What Does <b>Bivium Capital Partners, LLC</b> ("Bivium") Do with Your Personal Information?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. The information can include:</p> <p>Tax identification number (TIN), identity information, name, address, telephone number, email address, brokerage accounts and account holdings, balances, financial and family background, security transactions and investment objectives, net worth, income, and fee payment history.</p> <p>When you are no longer our client we may continue to share your information as described in this notice.</p>
How?	All financial companies need to share client personal information to run their everyday business. In the section below, we list the reasons financial companies can share their client personal information, the reasons Bivium chooses to share, and whether you can limit this sharing.

What we do	
How does Bivium protect my personal information?	<p>To protect your personal information from unauthorized access and use, we maintain physical, electronic, and procedural safeguards that comply with federal law. These measures include computer safeguards as well as secured files and buildings. We regularly evaluate our measures to maintain a high level of security and confidentiality.</p> <p>We restrict access to your non-public information to those employees and vendors who need to know that information to service your account.</p>
How does Bivium collect my personal information?	<p>We collect your personal information, for example, when you:</p> <p>Sign our advisory agreement, open a brokerage/custodial account, communicate with us, purchase or sell securities, deposit or withdraw funds, provide or update your investment profile, instruct your broker, custodian or bank to forward your statements to us, or grant us access to your statements.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit sharing only for;</p> <p>(1) affiliates' everyday business purposes – information about your creditworthiness;</p> <p>(2) affiliates from using your information to market to you;</p> <p>(3) sharing for non-affiliates to market to you.</p> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <p><i>Bivium has three affiliates: Bivium Capital Partners, Inc, Green Book Ventures and Beacon Rose Partners, LLC</i></p>
Non-Affiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p><i>Bivium will not share your information with any non-affiliates unless such sharing is necessary to service your account or is required by law.</i></p>
Joint marketing	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <p><i>Bivium has not entered into any joint marketing agreements.</i></p>
Other important information	
<p><b>For California Residents:</b> In accordance with California law, we will not share information we collect about California residents with nonaffiliates except as permitted by law, such as with your consent or to service your accounts. We will limit sharing among affiliates to the extent required by California law.</p> <p><b>For Nevada Residents:</b> Nevada law requires us to disclose that you may request to be placed on our internal "do not call" list at any time by calling [PHONE NUMBER]. **For Vermont Residents:** In accordance with Vermont law, we will not share information we collect about Vermont residents with nonaffiliates except as permitted by law, such as with your consent or to service your accounts. We will not share information about your creditworthiness with our affiliates except with your authorization.

**For Clients with a Massachusetts Address:** You may prevent disclosure of your information by registering with the Commonwealth of Massachusetts' opt-out program. For information, please contact the Commonwealth's Customer Security Bureau (CSB).
